- Technical Division - \$275.00** Persons, firms or organizations engaged in occupations pertaining to the supervision, regulation or investigation of underground water or ground water supply, or any teacher in a recognized institution whose field of teaching, research, or study is of interest to and/or associated with the water well industry.
- Associate Member - \$ 100.00** Any individual or organization who wishes to be supportive of the Kansas Ground Water Association, its goals and objectives, not eligible for any of the above divisions.
- Supplemental Contractor-\$100** Licensed or non-licensed employee of a company that has an active Contractor's Division membership.
- Supplemental Manufacturers & Suppliers-\$100** Employee of a company that has an active Manufacturers and Suppliers Division membership.
