The nominee must have no letters of infraction or violation with the KDHE.*

### **“Industry Recognition Award”**

#### *Action Honors Award*

Description: The Industry Recognition Award will be announced at the Annual Award Banquet. KGWA will recognize the KGWA Member who has contributed their time and efforts to the success of the Kansas Ground Water Association goals during the past year.

Criteria: *Person or Politician who has supported legislative action(s) to further the interests of the groundwater industry in Kansas and/or a licensed individual in good standing with the KGWA for the last 10 years.*

### **“Manufacturers and Suppliers Award”**

#### *Action Honors Award*
